## **Community Perception**

- During a Community Conversation for Hardtner's Achenbach Memorial Park Project, 31 attendees voted on potential park projects. Installing a disc golf course received 28 firstchoice votes.
- Eighteen participants selected improved seating as their secondchoice preference. Suggestions were made to incorporate Hardtner School's alma mater colors into park additions. Both the installation of a disc golf course and seating enhancements are anticipated.
- Conversations generated momentum towards future park improvements including preserving a fading mural and the possibility of a water feature. Considering the integration of memorials with new benches and picnic tables may provide additional funding for these enhancements.

# Initiative Wide: In general, my community has sufficient options for healthy eating.



### **Key findings:**

Nearly one-in-three respondents across the 24 *Pathways* communities said their community does not have sufficient options for healthy eating.

Results are based on data from an initative-wide survey of Blue Cross and Blue Shield of Kansas members for whom e-mail addresses were available in each of the 26 counties in which BCBSKS has funded coalitions as part of the *Pathways to a Healthy Kansas Initiative*. N = 3,708. The survey response rate was 5.3 percent. For this question, 3.2 percent of respondents did not provide an answer (blank response).
