





The **Healthy Harvey Coalition** works with community partners to improve the health, safety, and success of all people in Harvey County. Through the Pathways Initiative we are able to expand our partnerships and further our efforts by helping make substantial changes in policies, systems, and the environment that address the social determinants of health.

Community Perception

- 552 Harvey County residents were surveyed. Over three quarters (84%) of survey respondents rated Harvey County as healthy. Only 15% rated the County as unhealthy.
- · Almost two-thirds (63%) of respondents believe that Harvey County has plenty of options available for physical activity.
- Almost two-thirds (69%) of respondents think that commercial tobacco product use should be prohibited in all outdoor spaces.

Healthy Harvey Coalition is excited about the work Health Ministries Clinic is doing with Food as Medicine through Pathways and Sunflower

Active Living




Commercial Tobacco Control



As part of their new fitness equipment, Kansas Learning Center for Health is reviewing their tobacco free grounds policy and will be installing new signage to ensure that all community members using the equipment can experience a commercial tobacco-free space.

Initiative Wide: Level of support for commercial tobacco control policies in outdoor spaces



Key findings:

Three-in-five respondents across the 24 Pathways communities support commercial tobacco control policies in outdoor spaces.

Results are based on data from an initative-wide survey of Blue Cross and Blue Shield of Kansas members for whom e-mail addresses were available in each of the 26 counties in which BCBSKS has funded coalitions as part of the Pathways to a Healthy Kansas Initiative. N = 3,708. The survey response rate was 5.3 percent. For this question, 6.2 percent of respondents did not provide an answer (blank response)
