What is the overall deductible?	Network EE Only \$2,750; EE + Family: Individual \$3,400 / Family \$5,500. Non Network: EE Only \$2,750; EE + Family: Individual \$3,400 / Family \$5,500.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .				
		You will have to meet the deductible before the plan pays for any services. This <u>plan</u> covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply.
