What is the overall deductible?	\$1,500 person / \$3,000 family for In-Network. There is no coverage for Out-of-Network services. Doesn't apply to In-Network preventive care.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay.
