What is the overall <u>deductible</u> ?	\$4,900 person / \$9,800 family for In- Network. There is no coverage for Out-of- Network services. Doesn't apply to In- Network preventive care.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay.
